Anderson Satterwhite was born in North Carolina in Granville County in 1796

Nancy Ann Unknown Satterwhite future wife of Anderson was born in Georgia in 1796

Anderson married Nancy Ann Unknown Satterwhite in Georgia in Jones County in 1821

Anderson and Nancy Ann Unknown Satterwhite had their first child Mary J Satterwhite in Georgia in Jones County in 1821

Anderson and Nancy Ann Unknown Satterwhite had their second child David Satterwhite in Georgia in Jones County in 1822

Anderson and Nancy Ann Unknown Satterwhite had their third child William M Satterwhite in Georgia in Jones County in 1825

Anderson and Nancy Ann Unknown Satterwhite had their fourth child Edwin T Satterwhite in Georgia in Jones County in 1826

Anderson appeared in Georgia in Jones County, living next door to Michael S Childs, on the Federal Census of 1830

Anderson appeared in Alabama in Chambers County on the Federal Census of 1840

Anderson was issued a General Land Office Certificate for 103.74 Acres of land in Range 28-E Section 35, Township 23-N, Saint Stephen's Meridian, in Alabama in Chambers County in August of 1842

Edwin T Satterwhite son of Anderson was married Eliza Ann Veazy in Alabama in Chambers County by William Fuller Justice of the Peace on February 21, 1844
