**Martha Patsy Satterwhite Pettypool daughter of John Michael married Logustin P. Pettypool in North Carolina in Granville County on July 28, 1794**

**Stephen Satterwhite son of John Michael married Nancy Ann Knott Satterwhite North Carolina in Granville County on August 6, 1795**

**Mitchell Satterwhite son of John Michael married Lucy Knott Satterwhite in North Carolina in Granville County January 3, 1799**

**Martha Patsy Satterwhite Pettypool daughter of John Michael died in North Carolina in Granville County about 1802**

**John Michael died in Williamsboro, North Carolina in Granville County on March 24, 1804**

**Upon John Michael's death a new Registrar of North Carolina in Granville County was appointed in the May court of 1804**

**Stephen Satterwhite son of John Michel married Elizabeth Buice Satterwhite after the death of his first wife in Georgia in Jones County on September 29, 1833**

**Logustin P Pettypool son-in-law of John Michel died in Breckenridge, Kentucky in 1852**
