William Elijah Satterwhite was born in Alabama in Randolph County on November 19, 1862

Arizona A. Kerr Satterwhite future wife of William Elijah was born in Alabama on April 12, 1863

Jesse Thomas Moon future son-in-law of William Elijah was born in Alabama on September 20, 1898

William Taylor Satterwhite son of William Elijah died on October 22, 1898

William Taylor Satterwhite was buried in Union, Alabama in Randolph County in Union Baptist Church Cemetery in an unmarked grave shortly after his death

William Elijah appeared at S. D. 4; E. D. 56; sheet 2 A (99); Dwelling 23, Wedowee, Randolph County, Alabama; is 37, has been married 15 years, and he is farming. *Arizona has had 7 children, 5 are living.* Williams Elijah's mother Sarah Elizabeth McKinney Satterwhite is also living with them on the Census of June 5, 1900

William Elijah and Arizona A. Kerr Satterwhite had their eighth child David *Uncle Scott* Scott Satterwhite in Alabama on July 31, 1900

William Elijah died in The Line of Duty as Wedowee City Marshall of a Gun Shot Wound in Wedowee, Alabama in Randolph on December 2, 1905

Martha Reaves Kerr mother of Arizona A. Kerr Satterwhite died on March 1, 1918

Bertha Arizona Annie Satterwhite Moon of William Elijah married Jesse Thomas Moon before 1919

Arizona A. **Kerr Satterwhite** appeared at S. D. 5; E. D. 147; sheet 3 B, Wedowee Town, Randolph County, Alabama; is age 55, widowed and she is not working. Her children, David Scott Satterwhite and Carrie Bell Satterwhite are with her on the Census of January 9, 1920

Elder W. T. Boyd Chambers second husband of Jeffie Henrietta Smith Satterwhite Chambers was born on February 18, 1921

Sarah J. O. Hardigree Satterwhite daughter-in-law of William Elijah died on July 12, 1926

Arizona A. **Kerr Satterwhite** appeared at E. D. 56-8; S. D. 5; sheet 3 A (94), Wedowee, Randolph County, Alabama; is a widow, age 66. Daughter Bertha Arizona *Annie* Satterwhite Moon and her husband Jesse Thomas Moon are living in the next house on the Census of April 5, 1930

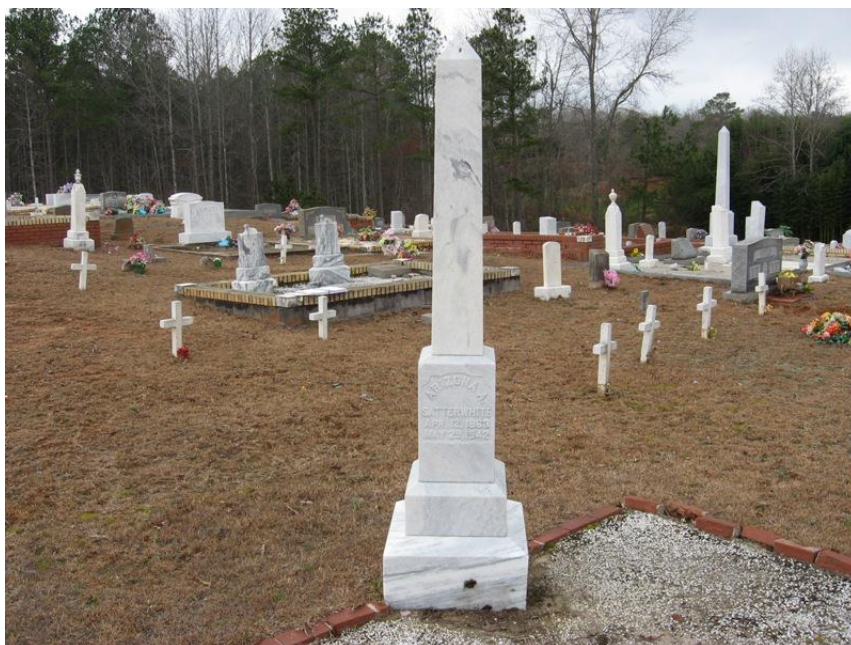
